Sudduth was a member of IBKC's original management team to grow a denovo franchise in Texas.

Prior to that role, she served in multiple leadership positions at Amegy Bank (ZION) focused on syndications, corporate banking, special assets and credit risk management. Sudduth earned bachelor's degrees in Business Administration and Arts from Southern Methodist University, as well as an MBA from Rice University. She serves on the Board of Directors and is the finance and audit committee chairperson for Discovery Green Conservancy.
