

# PNC Announces Redemption Of 2.000 Percent Senior Bank Notes Due May 19, 2020

PITTSBURGH, April 9, 2020 /[PRNewswire](#)/ -- The PNC Financial Services Group, Inc. (NYSE: PNC) today announced the redemption on April 20, 2020 of all of the outstanding Senior Notes due May 19, 2020 issued by PNC Bank, National Association in the amount of \$1,000,000,000 (CUSIP 69353RFC7). The securities have a distribution rate of 2.000 percent and an original scheduled maturity date of May 19, 2020. The redemption price will be equal to \$1,000 per \$1,000 in principal amount, plus any accrued and unpaid distributions to the redemption date of April 20, 2020.

Payment of the redemption price will be made through the facilities of The Depository Trust Company.
