A 28-year finance industry executive, MacNeil started her career in corporate finance with KPMG in Moscow, Russia and moved to Bank of America before spending the last fourteen years at Wells Fargo. During her time at Wells Fargo, she led diverse teams in middle market, large corporate and business banking, as well as operational risk and compliance. Most recently she served as the Commercial Banking Market Executive for Western Washington and Western Canada leading six teams across 10 geographies, focusing on closely held, private middle market and small businesses. MacNeil chaired the Diversity & Inclusion Council for Wells Fargo’s Commercial business nationally and served on the Reputation Management and Contributions Committees for Washington.

Active in the community, MacNeil serves on the board of directors for the Seattle Aquarium, where she chairs the nominating and governance committee, as well as serving as the 2020 fundraising chair for the Celebrity Waiter Luncheon benefiting the Seattle Millionaire Club Charity. She was awarded the Dallas Business Journal’s “Women in Business” recognition and the Puget Sound Business Journal’s “40 Under 40” award. MacNeil earned a Bachelor of Arts degree in Economics and European Studies from Vanderbilt University, and a Master of International Business Studies from the University of South Carolina.

Hare joined PNC earlier this year as the managing director and head of Corporate Banking for Washington State. Prior to joining PNC, she served in a variety of leadership roles at JP Morgan Chase, US Bank,

Microsoft and AT&T Wireless. Hare most recently served in a dual role as an Industry Executive and Market Executive for JP Morgan Chase in the Pacific Northwest, where she led the formation and growth of JP Morgan's technology and emerging consumer practice in Washington, Oregon and western Canada, while also serving as market leader to the middle market commercial banking team based in Seattle. She also is active in the Seattle community, serving as finance chair and board director for Washington STEM, a non-profit organization focused on advancing excellence, innovation and equity in science, technology, engineering and math education for all Washington students. Hare earned a bachelor's degree in Political Science from the University of Washington and Master in Business Administration from the Albers School of Business at Seattle University. She holds FINRA Series 24, 79 and 63 securities licenses.

Hutchinson has relocated to Portland from Philadelphia, where he served as senior vice president and managing director for PNC's Public Finance Group. He joined the bank in 2007 and spent the last 13 years supporting public finance. Hutchinson managed a team of bankers focused on providing comprehensive financial services, including capital raises, treasury strategy and investment management to public sector entities, including transportation agencies, municipalities, public utilities, education and 501c3 organizations. Additionally, Hutchinson was head of PNC's Public Finance national sector groups. In that role, he was responsible for integrating sector- and industry-based expertise to supplement regional business development across the United States. He earned a Bachelor of Arts degree in Philosophy, Politics and Economics from the University of Pennsylvania, and a Master in Business Administration from Villanova University.
