He continues to be an active member of Issue One, an organization of former senators, governors, and members of Congress committed to reform U.S. political and campaign systems.

Following his service in Congress, Ford taught public policy at Vanderbilt and the University of Michigan, and he worked in the private sector. Importantly, he spent a total of 11 years in key leadership roles at both Merrill Lynch and Morgan Stanley. He also has worked as a political commentator for both MSNBC and Fox News Channel, and he continues to provide political commentary for several networks. Ford currently serves on the board of directors of Live Oak Acquisition Corporation as well as the Lincoln Center, The POSSE Foundation and the River Fund New York.

He received a Bachelor of Arts degree in American History from the University of Pennsylvania and earned a law degree from the University of Michigan Law School.
